HCE has been selected by the state as a calibration school for the 2021-2022 school year, therefore our FSA dates will differ from other schools.

FSA Writing 4 th and 5 th grades	April 5
FSA ELA 3 rd grade	April 7-8

FSA Math 3 rd -5 th grades	May 9-10

COVID-19 Information

As we see an increase in COVID19 cases in our community, please review the SJCS D protocols found at <https://www.stjohns.k12.fl.us/covid-19/>. In addition, please take time to review the [Student Health Screening Entry Form](#). Should your child have any of the symptoms listed, please consider keeping them home. We may see an increase in mask use, while not mandated, it is an option for our families and staff. We will respect each other's choice. If you are interested in desk shields for your child, please contact your child's teacher directly.

On 9/22/2021, the Department of Health updated their emergency rule (64DER21-15) to include instruction student quarantines.

- 1. Student quarantines: (3)(a) Parents or legal guardians of students who are known to have been in direct contact with an individual who received a positive diagnostic test for COVID-19 may choose one of the following options:***
 - a. 1. Allow the student to attend school, school-sponsored activities, or be on school property, without restrictions or disparate treatment, **so long as the student remains asymptomatic**; or***
 - b. 2. Quarantine the student for a period of time not to exceed seven days from the date of last direct contact with an individual that is positive for COVID-19.***

If you choose to keep your child home to quarantine, please call the District COVID Support Team at 904-547-8230 to report your child on quarantine.
