4:35- Principal's Report

Y. Gonzalez reviewed FSA ELA Data Trend.Lowest performance was in 4th grade for proficiency. Grade level has been restructured with new teachers. Mrs. Gonzalez reviewed Learning Gains and Lowest quartile. 5th grade was highest in learning gains in Math in the county. Y. Gonzalez explained subgroup data. Students with Disabilities (SWD) is the lowest category. C Brown asked how SWD affected overall school grade. Mrs. Gonzalez and J. Brant, who is also an ESE teacher ,explained some aspects of growth and proficiency as it pertains to SWD. The F.A.S.T Assessment is new this year and replaces FSA. HCES will generate a baseline score to be compared to 2023-24 testing data. HCES will not generate a school grade this year. Testing is computer based 2 times a year. Last one will be summative and paper based. C. Brown asked for clarification of sub group demographics. Y. Gonzalez explained the variables necessary to generate a subgroup. Y. Gonzalez concluded the Principal Report by highlighting the plan of action in the School Improvement Plan :
